**How long will my appointment be?**

Non Executive Directors are appointed for 3 years from the British Marine Annual General Meeting, with the possibility of re-election for a further 3 years if they have served one 3-year term.

Your application will form part of the papers which will go to all members of British Marine Council, where it will be considered and voted on. Please bear this in mind when completing your application. Successful appointments will then be approved by the British Marine Annual General Meeting, from which point their terms shall begin.
